# Our Trial Team is Fighting for You

The courts and workers' compensation commissions in Maryland, Virginia and the District of Columbia continue to navigate the stay-at-home orders in each jurisdiction. Our trial team has been actively involved in the reopen plans for many of the courts and commissions so that our clients can get their day in court, even if that is done virtually.

The Maryland Workers' Compensation Commission has scheduled hearings, both in person and by web conference beginning June 8, 2020. In Virginia, the Workers' Compensation Commission will begin in-person hearings on June 11, 2020. They will continue virtual hearings as scheduled. The DC Office of Workers' Compensation is also scheduling virtual and telephonic hearings.

We continue to monitor the reopening plans for the courts in Maryland, Virginia and the District of Columbia. Civil trial dates have been scheduled for the fall. We are working on your cases.
